



The Challenge

The need for rapid conservation action is more significant than ever. Despite the availability of historic levels of public funding through the Great American Outdoors Act, the Inflation Reduction Act, and other sources, it often takes years to access these funds and many grants are on a reimbursement basis. The large volume of funds available and the slow pace at which it moves amplifies the need for bridge financing so communities can act swiftly on high-priority conservation projects. Without readily available capital, billions in public funding may go unspent, threatening national conservation goals.



Conservation Loan Collaborative

LegacyWorks Group is launching the Conservation Loan Collaborative (CLC) to meet the need for far more bridge financing. The CLC is a nationwide initiative designed to enable land trusts, tribes, associations, foundations, and coalitions to rapidly create and capitalize loan funds to provide the capital needed to seize high-priority conservation opportunities as they arise.

CLC combines the infrastructure and systems of a fund management company with the support and services of a nonprofit consulting firm to rapidly launch new funds. These funds then pool grants, investments, and low-interest loans from local, regional and national supporters to provide ready access to low cost capital to conservation practitioners. Our team provides all the expertise and support needed for our clients and partners to design, launch, raise, and manage loan funds so they can focus on and achieve their missions, far more rapidly.



How It Works
